## Rules and Regulations

Congratulations and welcome to the **Leather Colorado Foundation** family! We hope you are excited about competing, and we're glad you'll be part of the **Leather Colorado Foundation's Family of Contests**. Once you have read this application carefully and you have provided all of the information requested, deliver or mail the application to the **Leather Colorado Foundation** at the address shown below.

1. **Mr Leather Colorado™, Mr Colorado Rubber™, Colorado Bootblack™, Ms Leather Colorado™, and Miss Leather Colorado™** Contestants *may* be the winner of a bar or local leather contest (a "preliminary contest") past or present; **OR** be sponsored by a bar, business, club, or organization that specializes in the levi/leather, uniform, S/M, western, or related lifestyle **OR** represent themselves independently. If representing a business or organization, each such business or organization may only sponsor one contestant for each title.
2. To compete for **Mr Leather Colorado™** or **Mr Colorado Rubber™**, contestants must be male-identified. **Colorado Bootblack™** contestants may identify as any gender. To compete for **Ms. Leather Colorado™**, contestants must be female-identified. For **Miss Leather Colorado™**, contestants must be male-identified and participate in the drag community. All contestants must be 21 years of age or older and a resident of the state of Colorado as of the day that you register for the contest. In order to verify your eligibility to compete, ***include a copy of your government issued photo identification (driver's license, state ID, or passport) with your Contestant Registration packet.*** No person may compete more than 3 times for a title.
3. **Leather Colorado Foundation** staff will send a confirmation advising you when to check-in with the contest officials along with other detailed information. Once you submit your application, you will be working with the chair for that contest.
4. **Leather Colorado Foundation** Contestants are required to **provide all information in this application** and sign a Contestant Agreement and Contestant Photo Release Form stating that you will appear at all official **Leather Colorado Foundation** events, including, but not limited to, all portions of the applicable contest, photo sessions, and rehearsals. All contestants are also encouraged to participate in the Leather Contingent during Colorado area pride parades. Failure to appear at required events may result in disqualification from this or future contests. **Leather Colorado Foundation** reserves the right to refuse or remove a contestant from the competition at any time, for cause.
